

## Corona Virus (COVID-19) Scams

During any crisis there are those that would take advantage of a lower security stance by many individuals, businesses and organizations. Whether it is an individual malicious actor, group, or government sponsored hacking group.

Recorded Future has noticed a large increase of domain registrations specifically to emulate government health agencies or Corona virus specific sites. These domain registrations will be used to legitimize Phishing emails to make them appear to come from the CDC or WHO as well as many other foreign health organizations. The emails claim to have new information about COVID-19 and include attached files (Word Documents, PDF files, etc). These files contain a variety of computer malware. Other malicious actors are setting up fake websites in order to trick individuals into exposing information such as credit card, Social Security, login info or other personal information to be used in later hacking schemes. There are also those that ask for money directly for immunity boosting supplements, or even a cure.

### Things to look for:

**Beware of online requests for personal information.** A coronavirus-themed email that seeks personal information like your Social Security number or login information is a phishing scam. Legitimate government agencies won't ask for that information. Never respond to the email with your personal data.

**Check the email address or link.** You can inspect a link by hovering your mouse button over the URL to see where it leads. Sometimes, it's obvious the web address is not legitimate. But keep in mind phishers can create links that closely resemble legitimate addresses. Delete the email.

**Watch for spelling and grammatical mistakes.** If an email includes spelling, punctuation, and grammar errors, it's likely a sign you've received a phishing email. Delete it.

**Look for generic greetings.** Phishing emails are unlikely to use your name. Greetings like "Dear sir or madam" signal an email is not legitimate.

**Avoid emails that insist you act now.** Phishing emails often try to create a sense of urgency or demand immediate action. The goal is to get you to click on a link and provide personal information — right now. Instead, delete the message.
